Maple Leaf owns 22 homes, 1 multi-family home and one multiple use building in Geauga County, Ohio.

Maple Leaf has over 77 people who have special needs from Geauga County living in their homes in the community.

Maple Leaf is a 501 (c) (3) non-profit housing corporation.

Maple Leaf receives its support from the Geauga County Board of Developmental Disabilities, Tenant Rent, Fundraising, State and Federal Grants, Business donations, Local Civic Groups, and Individual donations.

Maple Leaf operates under a five-year contract with the Geauga County Board of Developmental Disabilities.

Maple Leaf has over 5.3 million dollars in real estate assets.

Maple Leaf has houses located in Bainbridge, Burton, Chardon, Chesterland, Hambden, Middlefield, Munson, Newbury, Russell and Parkman.

## What We Do

Maple Leaf's primary goal is to purchase homes, in which to provide residences for people referred to us by the Geauga County Board of Developmental Disabilities, GCBDD, Metzenbaum Center. Our responsibilities include their maintenance, with an emphasis on health and safety and required architectural improvements for people with particular disabilities. Maple Leaf is a non-profit corporation.

Most of our homes are four or five bedroom units with at least two bathrooms. We currently have twenty residences providing homes for four people each; we also have one condominium with three residents and one home with one resident.

One of our goals is to increase the number of homes available to our future residents.
